At the heart of and critical to the success of the Miami University Community Federal Credit Union lies its network of volunteers. At any one moment in time there are approximately 30 volunteers from our membership assisting us in some capacity. Typically, a volunteer is initially matched with one of many Credit Union committees based on his or her experience and expertise. This provides the volunteer with a unique opportunity to learn about our Community Credit Union and the credit union industry. Though not required, serving on a committee prepares one for future elected service on the Board of Directors.

Each year your Credit Union holds an annual member business meeting, wherein elections are held to fill positions on the Credit Union Board of Directors. In accordance with NCUA bylaws and your Credit Union's nominating policy, at least 120 days prior to the annual meeting your Board Chair recommends to the Board of Directors that a Nominating Committee be formed and its membership named. The Board of Directors must approve this recommendation. It is then the duty of the Nominating Committee to nominate at least one member candidate for each vacancy on the Board. Nominations for vacancies may also be made by petition signed by at least 1% of the members requiring a minimum of 20 signatures with a maximum of 500. When there is only one nominee for each open position, the election will not be conducted by ballot or by floor nomination. This year, nominations for Board candidates by petition will be accepted through July 31, 2012. Any interested members should contact Rick Parker for additional information and required procedures.

This year your Nominating Committee has recommended three knowledgeable, experienced, incumbent Board members to fill the three open Board seats:

Wilgus Banks

Board member since 1980, Wilgus is a graduate of Union High School in College Corner, retired from Miami's Zoology Department after working there for 32.5 years. - Shriver Center, lower level across from the food court by the student credit union office
- Johnston Hall, Middletown Regional Campus, across from the cashier's office
- Mosler Hall, Hamilton Regional Campus, across from the cashier's office

- Branch, 5120 College Corner Pike, 2 ATM's (inside the vestibule and drive-thru)

Our new *Nationwide ATM Locator Service* reduces the high cost of using foreign ATM machines. Traveling out of the area and need to locate a "Surcharge-free" ATM? Your Credit Union now belongs to the Alliance One Surcharge Free ATM Network. Simply visit our website at www.muccu.org, go to the contacts page,

browse over to *ATM Locator*, type in the city you are visiting and a listing of *No Surcharge ATMs* will be displayed. A *Surcharge* is a machine owner's fee that is assessed upfront at the time of your ATM transaction. Not to be confused with a *Foreign ATM transaction fee* is assessed after the transaction is completed and normally cannot be avoided. So! When traveling outside Oxford, let's eliminate the more costly upfront surcharge fee by using our new *Nationwide ATM Locator Service*.
